



## TALENT/MODEL RELEASE

THIS TALENT/MODEL AGREEMENT AND RELEASE ("Agreement"), as dated below, is between Manhattan Beach Studios LLC ("MBS") and the undersigned (and if the undersigned model/performer is under the age of 18, the model's parent/legal guardian) ("I", "me", "myself"). MBS shall include itself, its owners, agents, contractors, personnel and employees, The agreement is as follows:

### Verification of Age and Capacity

I verify that (i) I am eighteen (18) years or older at the time that any images, including photographs, videos or other renderings are created and/or taken ("images"), or (ii) I am under eighteen (18) years of age and am consenting personally, along with my legal parent or guardian for images to be taken.

I understand that I will be required to present proof of identity, legal authority, and age at the time of the session(s) and agree to provide a copy of my legal identification/driver's license upon request. I understand that there are potentially serious legal consequences to providing false statements or documentation of my age.

### Release

I hereby grant MBS permission to take images for its productions of me regarding the production identified as \_\_\_\_\_. I further give my irrevocable consent to MBS and its direct and indirect licensees, clients, and assignees to publish, republish, reproduce, distribute, or otherwise transmit the images of myself in any medium for all purposes, commercial or non-commercial, throughout the world. I understand that the images may be altered or modified in any manner. I hereby waive any right that I may have to inspect and approve a finished product or the copy that may be used in connection with an image that MBS has taken of me, or the use to which it may be applied. I further release MBS and its direct or indirect licensees and assignees, from any claims for remuneration associated with any form of damage, foreseen or unforeseen, associated with the use of these images.

### Compensation

I will be financially compensated for my professional services rendered during the contemplated session(s). The complete and total financial compensation package has been agreed upon by both parties and is as follows:

I understand that this represents complete and total payment. Upon receipt, I waive all rights to additional payment or remuneration for my services rendered during this session from MBS or any other parties, assignees or assigns, and I relinquish any right to compensation, financial or otherwise, from any future use of the images (or their derivatives) produced during this session. I understand that full copyright for all images produced during this session is retained solely and exclusively by MBS and that, by accepting payment, I have waived my rights to any present or future possession, personal or portfolio use, or commercial application of these images.

### Other Terms

I understand that I have the right to have one chaperone present during the photographic session (for models under the age of 18, a parent or legal guardian shall be required to attend the session) and that



if I waive this right I do so of my own will, thereby absolving MBS and all other personnel of any legal consequences or remuneration that may be associated with the absence of a chaperone. I understand that a combination of still or real-time, audio, image, and /or video recording may be in use during this photographic session. Such media may be used in any manner determined by MBS, including for promotion, marketing and other purposes. I hereby grant an unlimited license for the use of such recordings. Furthermore, I waive any right that I may have to such recordings and relinquish their ownership and full copyright to MBS.

I understand that it is my obligation to arrive at the agreed upon location by the agreed upon time and to be prepared and participate in the shoot for the agreed upon period. I further understand that violation of these terms may result in additional financial costs to me associated with lost investments of MBS' time, financial opportunities, monies expended in preparation for the session and that I agree to be held legally liable for these charges.

I (and my parent/guardian as applicable) shall complete a W-9 at the request of MBS.
